
 ALL dangerous goods - i.e. ALL aerosols - will become 'hazardous workplace chemicals'

# Weights & Measures

- Is going national from 1/7/2010
- New regulations gazetted in September - see www.measurement.gov.au
- 'Dual marking' and imperial accepted but MUST have weight in grams on front
- Average Quantity System and the 'e' mark
- Note: FEA STD 422: "Filled aerosol packs – Standard fill levels"

 'Greenwash' – make sure you qualify/substantiate any environmental claims

#### > EXAMPLES OF 'GREEN' MARKETING CLAIMS

#### PINE O CLEEN GLEN 20 SPRAY DISINFECTANT

CLAIM: The packaging says it is "CFC free". COUNTERCLAIM: The ACCC guidelines say claiming a product is CFC free is "meaningless" because CFCs have been banned in almost all aerosols.

#### SAAB

CLAIM: Advertisements last year claimed that "Saab is green" and promised that for every sale, 17 native trees would be planted to offset carbon dioxide emissions for the life of the vehicle. COUNTERCLAIM: The ACCC is taking legal action against 6M Holden, supplier of Saabs in Australia, saying that the ads were misleading and breached the Trade Practices ACt as the tree planting would only offset carbon emissions for a year.

#### WONDERSOFT TOILET TISSUE

CLAIM: The packaging has a symbol with the words "renew, reuse, reduce, rethink." COUNTERCLAIM The toilet noils are not made from recycled paper. The ACCC guidelines state that "sing a symbol that is widely accepted as having a particular meaning or affiliation... can be misteading"

HAR? and skin product manufacturer Natural Products of Australia will replace its "organic" and "natural" labels after court action by the Australian Competition and Consumer Commission (ACCC).

The manufacturer has agreed to relabel its Natural Instinct and Organic Instinct hair and skin care products after the ACCC alleged chemicals were contained in the Natural Instinct product.

Natural Instinct's management has undertaken to relabel its products, provide full refunds to affected customers and place corrective notices in Sunday newspapers and women's magazines throughout the nation, an ACCC statement said.

ACCC Deputy Chairman Peter Kell said the ACCC was concerned that inaccuracies in Natural Instinct's labels would mislead consumers about the composition of its products

"This is particularly important for consumers with allergies who need to avoid particular ingredients and chemicals," he said

"There is also a trend toward buying natural, organic and environmentally friendly products."

He said consumers should be able to rely on labels to provide accurate information about chemicals and other ingredients in cosmetic products

The ACCC said Natural Instinct did not list chemicals such as sodium laureth sulphate.

It also said it was concerned about statements that its products are "made withfrom 100 per cent pure oils and organic herbs" because it contained reliatively insignificant amounts of herbs and oils.



### ADG7

- Fully in place by 1/1/2010
- New UN/GHS flammability criteria adopted (SP63)
- Has LQ chapter (3.4)
- Available free on-line

## ADG7 (cont'd)

Totally delegates aerosol labeling to AS2278.

Table 5.1 (a) - "Aerosols should be marked in accordance with AS2278"

- Introduces provision for alternatives to the waterbath
- More detail re transport of 'waste' (reject) aerosols
- Recognises overseas standards
  - cl. 6.2.4.2 "Aerosol dispensers must comply with AS 2278 or an equivalent international or foreign standard"

# ADG7 (cont'd)

- Allows a new carton marking (below) for LQ loads (but the UN has just agreed on a new one !!)
- Makes explicit the ability to use shrink-wrapped trays
- The 'RDC' provision remains. See 'Chapter 7.3 Retail Distribution Loads'

# **HSNO (New Zealand)**

- Acceptance of 'overseas' labelling (to be extended beyond 2010?)
- Label needs "enough information to enable its New Zealand importer, supplier, or manufacturer to be contacted, either in person or by telephone"

### **Disinfectant Reforms**


- Second round of consultations to begin in October
